



AMENDED
MEMORANDUM OF SOCIETY
OF
MALWA RURAL EDUCATIONAL SOCIETY

1. The name of the SOCIETY will be MALWA RURAL EDUCATIONAL SOCIETY

2. The Society will have its office at S GURDEV SINGH KANG MEMORIAL RURAL INSTITUTE FOR CAREER COURSE BASSI GUJJRAN, NEAR CHAMKAUR SAHIB (ROPAR)

AREA OF OPERATION: DISTRICT ROPAR

3. The aims and objects of the Society shall be:

3.01. To take over, maintain, manage or administer and develop the education Institution or institutions at present administered and owned by or in the name of this society before registration, of this as society.

3.02. To establish, provide, maintain and administer schools, boarding houses, hostels, sports centers, welfare centres, hospitals, dispensaries, foundling-houses, and such other institutions and establishments which are for the cultural, moral, spiritual, social uplift of the human beings and are considered desirable by the society.

3.03. To diffuse social, moral, spiritual and secular knowledge and promote and publish literature consistent with the national heritage and thus conclusive to the welfare of the humanity as a whole.

3.04. To take over, establish and/or maintain, run, administer, develop and close down and dispose off schools, colleges, hospitals, libraries, reading rooms, research centres, training centres for Imparting education in physical and social science, fine arts, philosophy, culture, morality, Rural health, engineering or any field in the Interest of the nation/mankind humanity and for benefit and uplift of all persons.

3.05. To take over, manage, establish, administer, carry on, conduct, develop, equip, improve, alter and close down or dispose of educational, scientific and technical institutions, works and activities of all kind In any part of India irrespective of caste, creed, race and religion.

3.05. To support and promote the advancement of educational activities in all its branches, particularly schools, colleges, cultural, technical and social science centres and Institutions for all persons Irrespective of religion, race, cast, creed, community or social status.

3.07. To provide residential accommodation, equipment, facilities and maintenance to educate, train, and assist financially or otherwise in the education and training of social workers, staff, students and other personnel for the purpose of the Society.

3.08. To translate, print, publish, stock, circulate and distribute appropriate materials for the diffusion of useful knowledge and for the promotion, benefit and advancement of educational, scientific, technical, spiritual, cultural, moral uplift and charitable ideals and activities for the society in an outside the country.

3.09. To receive donations from National & International doners, contributions, subscriptions and grants and borrow and raise money which may be required for the purpose of the society upon bonds, bills of exchange, promissory notes or to other obligations or security of the or by the mortgage in charge of the society's property or any part thereof..

3.10. To subscribe or give donations financially or otherwise to aid educational and other institutions, works, activities which tend to support or aid the objective of the society by the reason of the locality of the operations of such Institutions.

3.11. To sell, Improve, develop, lease, mortgage, charges, dispose off, or otherwise deal with all or any part of the property of the society whether movable or immovable.

3.12. To establish, promote and assist in establishment and promoting and to subscribe to and become a member of any other society or Institutions, whose objects are similar or in part similar or the objects of the society, and the establishment or promotion of which may be beneficial to the society and to amalgamate therewith and to enter into the arrangements with such society or Institution to enable the members thereof to participate in the activities of the society.

3.13. To construct, maintain, alter, repair building, structures, etc., required for the society and to pull down and demolish such as are not required and to reconstruct and rebuild in place thereof.

3.14. To purchase, lease, secure by exchange or license hire or otherwise acquire any movable and Immovable property and any interest, easement, right and privileges necessary or convenient for the purpose of the society and to repair, alter moveable and Immoveable property of the society and undertake such other activities as may be necessary and incidental to give effect to the object of the society.

3.15. To establish, maintain and conduct and take over Institutes, teaching fine arts and crafts, music, painting, dancing and to develop the study of such subjects like fine arts and crafts, music, painting, dancing, etc. or to associates with such institutions in the development of teaching of fine arts and crafts, music, painting, dancing, etc. and train the members in mass media communication training.

3.16. To provide and encourage medical assistance in the form of hospital, Clinics and similar centres for all persons irrespective of religion race, caste community or social status.

3.17. To import effective training to the members and the staff and personal in academic, professional, and spiritual education.

3.18. To take over, establish, conduct and manage hostels, lodge and mass department for the benefit of the students, teachers, servants, working girls or others and to maintain such hostels and such departments.

3.19. To transfer any or all movable and Immovable properties to any body / Institution/ corporate organization for carrying out any of the above activities.

3.20. To frame bye-laws, rules and regulation for the conducts of the business of the society and its officers and employees.

3.21. To do all such other lawful acts, deeds and things as are Incidental or conductive to the attainment of the above objects or any of them.

3.22. To makes special provisions for Imparting physical training for improvement of the health of students, promote and introduce sports activities/games like Basket Ball, Volley Ball, Hockey, Foot Ball, Badminton, Table Tennis, Shooting, Lawn Tennis and any other games as such, Athletic activities like Hammer Throw, Discus Throw, Short Put, Javelin Throw, Pole Vault, Long Jump, High Jump, Weight Lifting and any other athletic activities concerned with sports like equestrian, driving, etc. and to teach discipline and manners to students and providing cultural advancement to the students with special facilities or N.C.C., Scouting, and collect/raise funds to promote such activities.

3.23. To organize deputations and cultural missions, for reaching the objects of SOCIETY in India and abroad.


3.24. To provide for holding exhibition, entertainment meetings, lectures, displays or classes and to undertake the publication of works, calculated directly or indirectly to advance the objects of the society.


3.25. To take, receive money, acquire movable and Immovable property or other valuable security by subscription or donation without giving the donor a right to the membership of the society and spend the same in the best interest of the institution and to maintain correct and proper accounts of the same, duly audited by the authorized Chartered Accountants.

3.26. To obtain recognition and financial assistance from the government and other Institutions to carry on the objects of the society.

Amendments:

3.27 The society will open a special school on its land for students with special talents and ability. Special teachers will be hired in this school and accommodation facilities will be provided to students and staff if necessary. These services will be free for the needy.

3.28 The society will also run an old age care center for the elderly on its land. Such seniors will be given facilities such as maintenance, medicines and entertainment

3.29 The society will open a convenience center in the public interest for the surrounding villages at village Bassi Gujran. Beneficiaries will be charged only government fees. Other services will be free.

3.30 The society may rent or lease a part of its building for the purpose of education.

3.31 The society can start a scheme to make illiterate people living in nearby villages literate on charitable basis.
